**ONE-WAY OR SINGLE TRIP MOVEMENT:** one move from the point of origin to the point of destination. Any additional stops between the point of origin and the point of destination are expressly prohibited. Single trip permits are effective for seven (7) consecutive days from the date of issuance unless otherwise directed by the City Engineer.

**ROUND TRIP MOVEMENT:** two trips over the same route in opposite directions. Round trip permits are effective for fourteen (14) consecutive days from the date of issuance.

**MULTIPLE MOVEMENTS:** Those in such close proximity to each other (in distance or in time) that the City Engineer would consider incorporating two or more permit moves within one permit application. Multiple move permits when granted by the City Engineer shall be for a period of time not to exceed ninety (90) days from the date of issuance.

**PUBLIC AND PRIVATE LIABILITY:** The permittee assumes all responsibility for injury to persons or damage to public or private property, including his own, caused directly or indirectly by the transportation of vehicles or vehicles and objects authorized under this permit. The permittee agrees to hold the City of Kankakee harmless from all suits, claims, damages or proceedings of any kind and to indemnify the City of Kankakee for any claim it may be required to pay arising from the movement.

**JURISDICTION:** The permit is effective only insofar as the City of Kankakee has jurisdiction and does not release the grantee from complying with other existing laws that may apply to the movement.

**RESTRICTION ON MOVEMENTS:** All movements made under authority of permits not specifying routes shall exercise due caution to prevent unauthorized use of any structure, highway, temporary route detour, runaround or turnaround. Posted max width, height, speed, gross weight or other restrictions shall be observed.

**LOCATIONS WHERE PERMIT IS NOT VALID:** Bridges over Interstate Highways are the jurisdiction of the IDOT, bridges over Illinois Tollway are the jurisdiction of the Illinois Toll Authority (630-241-6800). **RIGHT-OF-WAY DURING MOVEMENT:** Insofar as practicable, movements shall be confined to a single traffic lane and shall be made in such a manner that the rest of the roadway will be open at all times so the flow of other traffic will not unnecessarily be obstructed. Also, insofar as practicable, other traffic will be given the right-of-way over this movement. The driver shall remove the vehicle from the roadway when necessary to allow an accumulation of traffic to pass or when so directed by a police officer.

**SPEED:** Maximum speed shall be 5 m.p.h. below the posted speed limit, EXCEPT when otherwise specified on the permit. Legal weight, legal height movements up to and including 10 feet wide are allowed to travel at the legal maximum speed limit.

#### **ESCORT VEHICLES:**

**Civilian escorts and City of Kankakee Sheriff's Police** escorts may be required for any movement that exceeds legal dimensions as follows: 1) exceed 8'6" wide, or 2) exceed 13'6" high, or 3) exceed 55' long. The roadway geometrics and length of haul will be considered. As an absolute minimum, the following will be required:

One Civilian Escort is required for all moves that 1) exceed 14'6" wide, or 2) exceed 14'6" high, or 3) exceed 110' long. Two Civilian Escorts one in front of the load and one behind, are required for all moves that have a combination of two or more of the following; dimensions 1) exceed 14'6" wide, or 2) exceed 14'6" high, or 3) exceed 100' long.

**Three Civilian Escorts** are required for all moved that 1) exceed 16' wide, or 2) exceed 145' long or if the load exceeds 18' high.

City of Kankakee Sheriff's Police escorts are required for all moves that 1) exceed 18' high, or 2) exceed 18' wide, or 3) exceed 200' long and must be scheduled 48 hours prior to moving.

For all escort requirements see Sections 554.407 and 554.408 in the IDOT Policy Book.

### **EXCEPTIONS TO LEGAL LIMITATIONS:**

**Length Limitation Exceptions:** Vehicles operated in the daytime, except of Saturdays, Sundays, or legal holidays, when transporting poles, pipes, machinery, or other objects or a structural nature that cannot readily be dismembered, provided the overall length of the vehicle and load may not exceed 100 feet and no object exceeding 80 feet in length may be transported unless a permit has been obtained as authorized in Section 15-301 of the Code.

**Width Limitation Exceptions:** 1) Loads of Hay, Straw or other similar farm products provided that the load is not more than 12 feet wide. 2) Implements of Husbandry, as defined in the Code, being transported on another vehicle and the transported vehicle while loaded are exempt from width limitations.

**House Trailers:** The overall width of the house trailer includes doorknobs, awnings, or any other attachments. The towing until of house trailers over 8' but not more than 10' wide shall be at least a  $\frac{3}{4}$  ton truck. The towing unit of house trailers over 10' wide but not more than 12' wide and less than 115' long shall be at least a 1 ton truck with dual wheels. The towing unit of house trailers over 12' wide shall be at least a 2-ton truck with dual wheels. Movement of house trailers over 12' wide is prohibited when wind gusts exceed 25 m.p.h.

Overlength Objects: Movements of objects over 80' in length shall be equipped with two operating flashing amber lights – one over the cab of the vehicle; the other within 10' of the rear of the object, mounted as high as practicable over it.

**Oversize Load Signs:** OVERSIZE LOAD signs are mandatory on the front and rear of vehicles for loads over 10' wide, or 14'6" high, or 75' long.

**Red Flags:** The extremities of all oversize vehicles, vehicle combinations or loads, and all protruding objects shall be marked with clean red flags not less than 18" square.

#### PERMIT FEE SCHEDULE FOR OVERSIZE AND/OR OVERWEIGHT VEHICLE

Effective November 1, 2017

The following fees shall be sufficient to compensate in part for the cost of the extra wear and tear on the mileage of roads within the City of Kankakee of which the load is to be moved. The owner or his or her agent shall submit an application fee based on the below chart for a single routing valid for seven calendar days, round trip routing valid for 14 calendar days and multiple routings valid for a base period of three months. Permits may be issued for a maximum of four consecutive permit periods (365 days) with the permit fee calculated in the appropriate multiples of the base three-month multiple trip permit. Permits are valid only for the date periods specified on the permit and for the specific vehicle, load and routing as established by the City Engineer or designee. No substitution of vehicle, load or routing is permitted without expressed written permission by City Engineer or his or her designee and the permit must be carried in the vehicle to which the permit applies. With respect to over-dimension permits, the fee shall be sufficient to compensate in part for the special privilege of transporting oversize vehicle or vehicle combinations and load and to compensate, in part, for the economic loss of operators of vehicles in regular operation due to inconvenience occasioned by the oversize movements. For more detailed information, refer to the Illinois vehicle Code, Chapter 15 Size, Weight, Load and Permits.

NOTE: If a vehicle requires a permit due to multiple weight and/or dimension issues, the total fee will be based on the largest individual weight or dimension factor only.

#### **PAYMENT OF FEES**

The permit will not be issued until payment is received in full by the City of Kankakee. Payments may be made in the form of credit card, cash or check by contacting the Adjudication Office 815.936.3559. Checks are to be made payable to the City of Kankakee. All money received by the City of Kankakee shall be deposited in the City Highway Fund. No refund.
